It was explained that he has a licence from Sedgemoor District Council to rent out up to five pitches for a maximum of 30 days at a time each. The changes are reversible and the pitch area can be restored to how it was when required.

Location: The Coach House, Moor View Farm, Ashton Drove, Axbridge,

Somerset

Proposal: Erection of single storey stables/store

RESOLVED: To support this application with two conditions requested-

- 1. The equestrian facilities are for private use only and not used commercially
- 2. The stables remain ancillary to the dwelling
- ii) 15/21/00023

Location: The Coach House, Moor View Farm, Ashton Drove, Axbridge, Somerset

Proposal: Change of use of land to increase the residential curtilage, conversion of ground floor to residential, erection of a porch to front (NW) elevation, installation of dormer to side (NE) elevation, erection of a dual pitched roof over existing courtyard and erection of detached single storey carport/gym and workshop on site of existing (to be demolished).

RESOLVED: To support this application by three votes to two with observations regarding technicalities for the wording of the application as follows-

- 1. The "proposed extensions" is a confusing term on the design access statement.
- 2. Permission to demolish part of the building appears to be missing.
- 3. The footprint appears to be increased when it is purporting to have the same area due to the creation of a porch

Proposal: Erection of an agricultural building, workshop and equestrian

building with the formation of yard area and associated works.

RESOLVED: To unanimously support this application with a condition requested that it must be for agricultural use only.

Location: Rose Cottage, Front Street, Stone Allerton, Axbridge, Somerset,

Proposal: Erection of first floor extension, erection of a single storey

extension to the rear (East) elevation and refurbishment.

RESOLVED: To unanimously support this application with an observation that there should be sufficient off road parking provision as members were unable to establish the exact curtilage of the site and building, and that there should be no cars parked on the road as entirely unsuitable for parking.

Proposal: Conversion of redundant agricultural building to form a single

dwelling.

RESOLVED: To unanimously support the changes to the application which was originally supported by this council.
