Sparrow Hill Way, Weare	From its junction with Notting Hill Way to its junction with Brinscombe Lane
Pipers Close, Weare	For its entire length
Splott, Weare	For its entire length
Alston Sutton Road, Weare	From its junction with Brinscombe Lane southwards for 300 metres
Mill Lane, Weare	For its entire length
Greenhill Lane, Weare	From its junction with Mill Lane northwest for 100 metres

Badgworth Lane, Weare	From its junction with Notting Hill Way westwards for 140 metres
Wheatsheaf Lane, Weare	For its entire length
Weare Road, Weare	From its junction with Wheatsheaf Lane to the junction with Rawlings Lane a distance of 660 metres
Dunkery Road, Stone Allerton	For its entire length
Notting Hill Way, Stone Allerton	From its junction with Sparrow Hill Way to its junction with Wheatsheaf Lane
Front Street, Stone Allerton	For its entire length
Stone Allerton Drove, Stone Allerton	For its entire length of tarmac surface, a distance of 580 metres
Copsewood Lane, Stone Allerton	From its junction with Stone Allerton Drove to its junction with Short Lane
New Road, Stone Allerton and Chapel Allerton	For its entire length
Short Lane, Chapel Allerton	For its entire length
Rectory Hill, Chapel Allerton	For its entire length
Rawlings Lane, Chapel Allerton	For its entire length
Back Lane, Chapel Allerton	For its entire length
Front Street, Chapel Allerton	For its entire length
Ham Lane, Chapel Allerton	For its entire length of tarmac surface, a distance of 90 metres
Mark Road, Chapel Allerton	From its junction with Front Street westwards for a distance of 600 metres
